Grand Opening a Big Success

Close to 100 people came to the Grand Opening of the exhibit, "Liberty Awakes in Washtenaw County: How Women Won the Vote" at the Museum on Main Street on a cold Sunday afternoon in January. Co-sponsored by the League of Women Voters of the Ann Arbor Area and the Washtenaw County Historical Society, the exhibit was put together by co-curators, Zoe Behnke and Jeanine DeLay. Both League members, Zoe and Jeanine have devoted countless hours to this project. The result is a professional exhibit showing letters, photos, newspaper articles and other artifacts depicting suffragist activities in Washtenaw County from 1910-1920. If you haven't already seen this acclaimed exhibit, I encourage you to do so. The exhibit at the Museum on Main Street, 500 North Main, is open every day, noon to 4 pm until February 27. Zoe Behnke will be there to welcome you.

Program Planning for 2011-13

Twelve League members gathered at Paesano's last month to give guidance to the League of Women Voters of Michigan Board and to our Local League Board. Members supported the concept of a state-wide study on "Redistricting". Doing a study will enable us to develop a state position so that we can lobby the state legislature. Jeanine DeLay and I started working on this exhibit about two years ago. This exhibit melds the local history of the movement with the national and international exhibit. The exhibit includes information boards and artifacts. After meeting with Susan Nenadic and her staff at the museum, Jeanine brought in Steve Maggio, a graphic designer, who looked at the design and offered suggestions on how to make it flow from room to room and to accent the artifacts. Then Jeanine took my information and her information and wrote the texts for the boards. She brought in Linda Fitzgerald, an experienced copywriter, who assisted with the editing of the boards.

I contacted CTN and the on-line newspapers. James Dickson (Ann Arbor.com) is writing an article on it. Jodie Mason (A2Journal) wrote two articles and recorded a video. Jodie's articles can be viewed on A2Journal.com (type "Liberty Awakes" in search). Also, A2Journal's first article appeared in Ann Arbor, Saline, and Milan Heritage Newspapers. Lucy Ann Lance interviewed Jeanine, Saturday, January 15th, for her Saturday morning radio program (which can be streamed on your computer, Lucy Ann is at 1290). CTN took pictures at the museum for its "FYI" program.

Sue, Jeanine, and I did a half hour taping for CTN in October. It can be streamed on your computer, or you can call CTN to have it replayed. The three of us spoke at the Bentley Library on the history of suffrage and the exhibit for the Washtenaw County Historical Society November lecture. Forty people attended that event.

We would like to thank everyone who loaned artifacts for the exhibit. Peggy Hiss loaned us a picture that included her Mother, Grandmother, and Great-Grandmother sitting in a car for a suffrage parade in Ohio.

We have received many compliments from the visitors. Additionally, visitors have returned with their friends.

YEARS AND YEARS AND YEARS

Many thanks to each and all of you who have paid your individual or household membership dues for the calendar year 2011. You are fully paid until December 31, though you will be asked to make a renewal payment this fall. Generally members who pay after July 1 are considered paid for the remainder of that year and the year to come. (Good deal for new or lapsed members!) The calendar year is our membership year for local members to pay and also for local Leagues to make their Per Member Payments (PMP) to both the State and the National Leagues.

Our (as well as the State and National) fiscal year runs July 1 through June 30. This is a bookkeeping year and has little effect on the membership except through the Treasurer's monthly reports and the Budgeting process.

Our program (meetings and action) year tends to be September through May. Many projects and Voter Service work, however, come during the summer months, so we never officially head off on holiday.

WHY REDISTRICTING MATTERS – Nancy Schewe, VP-Membership

Redistricting should foster the democratic principle of allowing voters to choose their elected officials rather than be a process in which we allow our elected officials to "choose their constituents."

Now that the 2010 Census is complete, federal law requires that state and local governing bodies begin the process of redistricting if there have been significant shifts in population since the last census. The Census Bureau has an April 1 deadline for sending data to the states and then on to local levels. Once the data is received, each governing body will begin its work of creating redistricting plans, which must be complete in time for the next election cycle.

The LWVUS promotes four essential principles to assure representative government:

1. An accurate and complete count in Census 2010 is an essential building block for all redistricting efforts;
2. The process used for redistricting must be transparent to the public;
3. The redistricting process, at all levels of government, must provide data, tools and opportunities for the public to have direct public input into specific plans under consideration by the redistricting body;
4. In order to achieve representative democracy, redistricting plans must be drawn in a manner that allows elected bodies to reflect the diversity of the populace, especially racial and ethnic diversity.

In Michigan, the state legislature will draw lines for U.S. Congressional Districts and the State Legislature. In Washtenaw County, an Apportionment Commission, consisting of the County Clerk, the County Treasurer, the Prosecuting Attorney, and the Chairs of the two major parties, has sixty days to select a districting plan. This commission also determines how many districts there will be. Once the plan is complete, it must then be presented for public comment. The City of Ann Arbor has a similar process.

The Ann Arbor Area League is in communication with the clerks of both the City of Ann Arbor and Washtenaw County and has offered to host a community forum presenting the new redistricting plans to the public.
