You may set up an appointment by phone, letter, or email. Meetings of government bodies, including committees, are open to the public except for discussion of property purchases or personnel matters. Regular meetings permit time-limited comments from citizens during audience participation.

VOTER INFORMATION

REGISTERING TO VOTE

To register to vote, you must swear or affirm that you:

- (1) are a citizen of the United States;
- (2) will be at least 18 years old by the next election;
- (3) will have resided in Ann Arbor (or your city or township) and registered at least 30 days prior to the next election date. No periodic re-registration is necessary. NOTE: Driver's license, address and registration address must be the same.

You may register at:

- (a) a city, township, or county clerk's office,
- (b) any Secretary of State office,
- (c) one of the permanent registration sites, whose location may be obtained from the clerk's office.

If you move within a city or township, you must file a change of address with the clerk. If you move to another city or township within the state, you must re-register with the clerk in your new city or township of residence.

ABSENT VOTING

Absent Voter Ballots must be requested in writing. For detailed instructions phone your clerk. Registered voters may apply to vote by absent voter ballot if they:

- (1) will be absent from the city (or township) on election day during voting hours;
- (2) are unable to attend the polls due to physical disability or religious tenets;
- (3) are 60 years of age or older, or
- (4) are confined to jail awaiting trial.
